Starting April 9, 2006, Italy has applied the Artist's Resale Right, which is a royalty payable to artists (alive or deceased less that 70 years) of the figurative arts and of manuscripts for each sale of his works of art Subsequent to the first sale. Resale royalty will be charged to the Vendor it will be applied where the hammer price is 3.000,00 Euro or More. The artist's remuneration is calculated on a percentage of the net sales price, which varies according to the Category it falls into:

4% for the portion of sale price up to 50,000.00 Euro

3% for the portion of sale price between 50.000,01 and 200.000,00 Euro

1% for the portion of sale price between 200.000,01 and 350.000,00 Euro

0,5% for the portion of sale price between 350.000,01 and 500.000,00 Euro

0,25% for the portion of sale price above 500.000,00 Euro

The total remuneration cannot exceed 12.500,00 Euro.

Once we receives the Artist's Resale Right by the Vendor, we will rebate that amount to the SIAE (Società Italiana Autori e Editori).

- 1. The lots are sold in premises open to the public by us which acts an agent, on an exclusive basis, on behalf of each Seller, whose names are registered in special books held at us. The Sale shall have direct effects upon the Seller and us shall not be liable towards the Buyer or any third party except in respect of responsibilities deriving from its role as agent.
- 2. The lots are knocked down to the highest bidder and by cash, if any dispute arises between two or more bidders, the disputed lot shall, at the sole discretion of the auctioneers, immediately be re-offered and resold.
